Finals--StepLadder Roll-Off--Begins Immediately After Head-To-Heads

(Bowling Linage-\$23.60; Awards Fee-\$2.00 returned at least 100%

Expense Fee-\$4.50; Scholarship Fund-\$9.90)

- Open to USBC Youth Division members in good standing and USBC Collegiate Division members who have not violated USBC Youth Division Rule 400, the eligibility rule. Presentation of USBC Membership Card required to become a TSRSA member.
- 2. Competition will be scratch--no handicap allowed--in 2 divisions--Male and Female.
- 3. Entry Deadline--9:30 AM Saturday morning of the tournament. Proper attire required. Bowlers must wear collared shirts. Dress pants or jeans are allowed providing jeans are not torn. Pants must be worn at the natural waist line. No shorts. No headbands unless for medical reasons.
- 4. Entry Fee-\$40 (\$23.60 linage fee, \$2 awards fee, \$4.50 expense fee, \$9.90 Scholarship Fund). An additional \$5 will be charged to all entries not paid by 9:30am and will go towards the scholarship fund. A \$20 Membership Fee is required upon entry for an individual's first tournament of the season. Membership Fee is a one-time per season charge of which \$7.50 will be used for tournament related expenses and \$12.50 will go into the TSRSA Scholarship Fund. <sup>\*</sup>A \$20 Membership Fee is required upon entry for an individual's first tournament of the season. The Membership Fee is a one-time per season charge of which \$7.50 will be used for tournament related expenses and \$12.50 will go into the TSRSA Scholarship Fund.

- 5. Bowlers will switch lanes after each game of competition, except in the Finals. Pinfall is carried forward after the Qualifying Round only. Pinfall is dropped after the Head-To-Heads.
- 6. The Top five finalists-male division, top three-female division will complete in a pro style roll-off to determine the Champions. Awards will be given to the 5 finalists-male division and female division, and the high game winner in each division. Additionally, scholarships will be awarded as follows:

  Male division- 1st-\$325, 2nd-\$225, 3rd-\$175, 4th-\$125 and 5th-\$75. Female division- 1st-\$225, 2nd-\$125 and 3rd-\$75. Masters-Male division- 1st-\$425, 2nd-\$275, 3rd-\$175, 4th-\$125, 5th-\$75, and Female division- 1st-\$325, 2nd-\$175 and 3rd-\$75. Additional \$75 scholarships will be awarded as need to comply with USBC rule 308c. Scholarships are partially funded by participating centers and other sponsors as indicated. Scholarships are administered through the SMART Program Account number 10711.
- 7. All ties will be broken by a one game roll off, except in the finals where a 9th and 10th frame roll off will be used. If a tie still exists after the tie breaker, the tie breaker will be repeated until the tie is broken.
- 8. Alternates, as determined by order of finish, will be used as necessary. Alternates when used shall be credited with the total pinfall of the bowler being replaced at the time of substitution less 100 pins.
- 9. A Bowler of the Year will be named for each division. The Bowlers of the Year will be determined on a point basis. The male and female bowlers who achieve the greatest number of points will be declared the Bowlers of the Year, and awarded a \$600 Scholarship each. Points are awarded for participation, place of finish, high games, average, etc.
- 10. USBC rules will govern this tournament, and the tournament director's decision shall be final unless an appeal is made to USBC. Claims for errors in scoring must be made to the tournament director no later than 30 minutes after completion of the block, or before awards are presented, whichever comes first. Protest involving eligibility or general playing rules must be confirmed in writing to the tournament director before the commencement of the next round. Each protest under this rule must be specific in itself and this rule shall not be construed to cover a previous or similar violation. All matters not covered by these rules shall be decided by the Tournament Co-Directors, Dot Collins and Teresa Lyday, and Tournament Assistant Michael Lyday.
